

FMJ ULTRATM (FULL METAL JACKET) SUPERIOR ADHESION SPRAY POLYUREA TRUCK BEDLINER



DESCRIPTION

The FMJ ULTRA[™] pure polyurea protective spray-on bedliner is formulated with SPI's cutting-edge Ultra Bond[™] technology. SPI's advanced Ultra Bond[™] chemistry is coined "the duct tape molecule". This significant coating industry advancement provides a unique advantage of adhering to many inorganic and organic surfaces (both new and aged) without a primer or extensive surface preparation. Like duct tape, FMJ ULTRA[™] gains adhesion strength over time. Save labor by eliminating the costly step of sanding, abrading or chemical-etching the bedliner surface. Just use soap and water to create a clean, dry surface. If oxidation is present the surface must be abraded.

This product is ideal as a protective liner for pickup truck beds, automotive undercoating, and similar applications.

FEATURES

- 100% solids. No solvents. No VOCs.
- Fast-set: handle in one minute or less.
- It can be sprayed in temperatures as low as *60°F (16°C).
- High dry temperature stability to 250° F (121 °C) with intermittent temperatures to 300° F (148 °C).

*To minimize the risk of thermal shock to the coating during, and immediately following application, insure substrate temperature is at or above 60°F (16°C) prior to and during spray application. Substrate temperature must remain at 60°F (16°C) for four hours or 70°F (21°C) for two hours minimum following application.

COLORS

FMJ ULTRA[™] is available in SPI high pigment Black. Custom colors will be quoted upon request. It should be noted that FMJ ULTRA[™] is an <u>aromatic</u> polyurea; therefore, as with all aromatic, color change, and superficial oxidation will occur.

<u>Aliphatic</u> urethane, polyurea, and other suitable aliphatic topcoats can be used when long-term color stability and increased longevity in full sun exposure are of critical importance.

*All cured film properties are approximate since processing parameters, ad-mixture types, and quantities change physical properties of the cured elastomer. All samples for above tests were force cured or aged for more than three weeks. It is recommended that the user perform their own independent testing.

**Complete polymerization to achieve final strength can take up to several days or weeks depending on a variety of conditions or product type.

The samples for tests were sprayed with Graco HXP3 [®] 3000 psi (16.68 mpa). Primaries/Hose Heat 170°F (76°C) Fusion MP Gun w/XR2929 module and .040 ceramtip.

Apply FMJ **ULTRA™** only to clean, dry, sound surfaces free of loose particles or other foreign matter. Consult technical service personnel for substrate preparation procedures.

FMJ ULTRA[™] can be sprayed over a broad range of ambient and substrate temperatures. Contact technical service personnel for specific recommendations, pricing, and availability of spray and auxiliary equipment.

It is recommended that FMJ ULTRATM be sprayed in multidirectional (north-south/east-west) passes to ensure uniform thickness.

The polyol "B" component must be thoroughly power mixed each day, prior to use. Contact a SPI technician regarding proper mixing equipment.

Follow the instructions attached to "A" and "B" containers.

RECOMMENDED EQUIPMENT AND SETTINGS

- Standard 1:1 ratio, heated, plural-component equipment developing a minimum of 2000 psi (10.4 mpa) dynamic pressure with heating capabilities to 175° F (79 °C) will adequately spray FMJ ULTRATM. These include Graco 20/35, 20/35 Pro, H-2000, H/3500, E-XP1, E-XP2, H-25, H-40, H-XP2, H-XP3, PMC Classic PH & GH series, PMC PMC PA series, and SPI Gusmer 25/25. Gun models include Fusion MP, Gap Pro, Glass Craft P2, P2 Elite, P2 Elite "C", GX-7 DI, and GX-8 Pro gun.
- Pre-heater temperature should be at 160-170°F (71-76 °C).
- Hose temperature should be at 160 -170° F (71-76°C). A hose thermometer inserted under the insulation near the gun should read a minimum of 145-155°F (63-68°C).
- Physical properties will be enhanced when sprayed at higher pressure (3000 psi or more) (20.8mpa), utilizing an impingement mix gun such as MP Fusion or GX7-DI.

MIXING AND THINNING

The polyol "B" component must be thoroughly power mixed each day, prior to use. Contact a SPI technician regarding proper mixing equipment.

Thinning is not required. Using any thinner may adversely affect product performance.

CLEAN UP: Use DPM, NMP, and Polyclean.

SKIN PROTECTION: Chemical resistant gloves are recommended. Cover as much of the exposed skin area as possible with appropriate clothing.

RESPIRATORY PROTECTION: Use a respirator approved for isocyanates and organic vapors. If you are not sure or not able to monitor levels, or if you are spraying in an enclosed/indoor area, use MSHA/NIOSH approved supplied air respirator. Consider the application and environmental concentrations when deciding if additional protective measures are necessary.

INGESTION: Do not take internally. It is believed that ingestion of polymeric isocyanates would not be fatal to humans, but may cause inflammation of mouth and stomach tissue.

LIMITATIONS

- This product is for professional use only.
- FMJ ULTRA™ must be stored at temperatures between 60° F to 90° F (15 °C to 30 °C).
- Liquid temperature in drums during application 70°F (21°C) 100°F (38°C).
- Apply FMJ ULTRA ™ when surface and air temperatures are above 60°F (15°C) and rising, and 7°F (-13°C) above dew point.
- Minimum material/container temperature for spray application is 70°F (21 °C).
- Avoid moisture contamination in containers. Containers should not be resealed if contamination is suspected, CO₂ created pressure can develop. Do not attempt to use contaminated material.
- Undried air exposed to liquid components will reduce physical properties of the cured coating.

Note: The material supplied is two components (Component "A"/Component "B") used to formulate FMJ **ULTRA** TH The quality and characteristics of the finished polymer is determined by the mixture and application of the two components.
